Executive Summary

Established in 2012, Africa's Best Cocoa Cooperative (ABC) is based in Zolowee, a village in Nimba County, Liberia—approximately 270 km from the national capital, Monrovia, and 11 km from the county capital, Sanniquellie. ABC sources fermented, sun-dried cocoa beans from over 1,000 smallholder farmers. Most of these farmers cultivate cocoa on family-owned land, while others are sharecroppers who provide seasonal labor in exchange for a portion of the cocoa yield, which they sell for income.

ABC's estimated maximum annual production capacity is 1,200 metric tons (MT), with 425 MT currently available for trade. While cocoa beans remain ABC's primary product, a local NGO investment—supported by international funding—has equipped the cooperative with a winnower, enabling production of approximately 20 MT of cocoa nibs per year.

All contributing farmers are certified organic. The cooperative uses the heap fermentation method and dries beans on raised tables under the sun. Thanks to continued NGO support, ABC also has access to a solar-powered dryer for use during the rainy season.

ABC maintains a paper-based traceability system that tracks cocoa purchases at the farm level. The cooperative possesses a moderate number of logistics and quality control assets. Throughout ACM's due diligence process, ABC has been a cooperative and engaged partner, providing requested information promptly and transparently. The cooperative leadership has expressed strong interest in securing direct trade relationships with international buyers.







Risk Assessment

ABC Cooperative maintains farm-level traceability using a paper-based logbook system; however, these records are not currently audited. A digital traceability system is under development, but buyers seeking access to ABC's traceability data should anticipate a minimum turnaround time of one month. As with many cooperatives, financial transparency is limited. We found insufficient evidence to assess the cooperative's governance model beyond their stated claim of having a functional executive board. These risks may be partially mitigated by ABC's partnership with a local NGO, which has previously provided training and operational support.



EUDR Compliance Summary

ABC Cooperative has not yet exported cocoa accompanied by an EUDR due diligence statement. Through its organic certification process, ABC holds geolocation data for all or most contributing farmers. To assess deforestation risk in line with EUDR requirements, these records will need to be shared with a qualified compliance service provider at an additional cost. On the legal compliance side, the cooperative has provided a general statement affirming adherence to national laws. However, buyers intending to import cocoa into the EU should engage an EUDR compliance provider to conduct further legal risk assessment and fulfill due diligence obligations.
